Switzerland's commitment to human rights and new challenges with regard to Covid-19

Findings and learnings from the Roundtable Human Rights Impact Assessment in Thailand and Myanmar

In 1996, she founded ALTSEAN-Burma to develop innovative human rights training and advocacy programs. She is a member of ESCR-Net Corporate Accountability Working Group Steering Committee, and the Innovation for Change Global Governance Circle. She previously served as Secretary-General of FIDH, the International Federation for Human Rights (2013-2019).

She works with communities to engage states, IGOs and other stakeholders throughout Asia, Africa, Europe, and the Americas. She has developed training programs focused on the thematic priorities of business and human rights (BHR), human rights-focused macro-economic policy, atrocity prevention, and women's leadership. Accordingly, she has either facilitated or been a resource person at 300 training events in the past 14 years, with many of these trainings delivered to grassroots activists in small towns, and



conflict-affected zones. She presents regularly in international fora on BHR issues and has ongoing engagement with the development of the UN Binding Treaty on Transnational Corporations, and the UN Guiding Principles on BHR.



Nina Sahdeva Ndotoni became part of *fair unterwegs* - *arbeitskreis tourismus & entwicklung (akte)* in 2006, when she had already completed four years of studies in history, ethnology and English, had given birth to three children, had worked for various NGOs and had received her training and diploma at the Media training center MAZ. At akte she works as a journalist/editor mainly for the portal fairunterwegs.org and is involved in akte's educational assignments in the specialized tourism training. In 2019 she completed her master's degree in clinical psychology and neuroscience. She contributes her psychological knowledge to the akte project "from knowledge to



action", which develops ways and means to coach travellers in the implementation of their ideas of sustainability.

Session 5: How to improve conditions for migrant workers and prevent modern slavery and why it is relevant for investors relations



Andy Hall is a British human rights defender and a migrant worker rights specialist. During almost 12 years in Thailand, Andy became an internationally recognised human rights defender, migrant worker rights specialist and campaigner working on migrant worker rights, empowerment and modern day slavery issues in global supply chains, particularly with impoverished and exploited migrant workers from Myanmar. In addition to his key role since 2009 as an international affairs advisor to the Migrant Worker Rights Network (MWRN) in Thailand, Andy also founded the Human Rights and Development Foundation's (HRDF) Migrant Justice Programme in 2007, was a foreign expert in migration at the Institute for Population and Social Research (IPSR) at Mahidol

University from 2011 to 2013 and during 2013 was an advisor to the Myanmar government under an EU funded migration project. Andy decided to leave Thailand in November 2016 due to an evident increase in risks to his person and ability to work effectively from employers launching criminal prosecutions against him as a result of his advocacy campaigns responding to worker abuses. Andy is currently continuing his advisory work to civil society, business organisations, governments and investors on issues of migrant worker rights in global supply chains, with a particular focus on Malaysia and the Gulf/Middle East.

Antje Monshausen works as policy advisor for Tourism and Development at Bread for the World (BftW) - Evangelical Development Service, and has been head of Tourism Watch since 2012. Tourism Watch is part of the policy department of Bread for the World. As a development agency of the Evangelical Regional and Free Churches in Germany, BftW works together with ecumenical partners to promote sustainable, socially responsible and environmentally sound tourism and publishes the quarterly information service "TourismWatch". It focuses in particular on the connection between climate justice and tourism as well as questions of human rights-oriented tourism development.



Antje is chairperson of the board of the Roundtable Human Rights in Tourism, second chairperson of the board of the child rights organization ECPAT Germany and member of the certification council of TourCert. Internationally she is one of the initiators of the "Transforming Tourism Initiative", in which non-governmental organizations from numerous countries of the global South and North have been exchanging ideas since 2017. She holds a degree in geography with an accompanying degree in Latin American studies.
